II. <u>Course Objectives</u>

Course Summary: FIN 3334 This class focuses on the instruments, techniques, and institutions of real estate finance; sources of funds; mortgage risk analysis; emphasis on typical policies and procedures used in financing of residential, industrial, and commercial properties. The course will also examine the valuation of various mortgage instruments and mortgage-related securities. It is intended to prepare individuals for future careers in real estate and finance.

Learning Outcomes: At the end of the course, students will be able to:

- Understand the economic foundations of US real estate markets
- Evaluate risks and returns associated with mortgage instruments and mortgage-related securities
- Differentiate between the primary and secondary mortgage markets
- Recognize the role and importance of real estate-backed securities
- Appreciate the effect of financial regulation on the US real estate market
- Understand common real estate financing structures
- Develop basic real estate cash flow models

III. <u>Course Procedures</u>

Required Text: Terrence M. Clauretie and G. Stacy Sirmans. *Real Estate Finance: Theory and Practice*, 7th edition. OnCourse Learning, 2014.

Blackboard: Course announcements, handouts, supplemental readings, lecture slides, and grades will be made available through Blackboard. Students are expected to regularly check the class Blackboard site for announcements. Students are expected to read assigned materials ahead of the class lecture and discussion on that topic.

Financial Calculator: Students are required to have a financial calculator.¹ Any basic financial calculator will suffice for this course, but the student is responsible for understanding how to operate it. Calculators that store text or transmit data are not permitted to be used on the exams (this includes cell phones). Sharing calculators during exams is prohibited.

Outcome Measurement:

- There will be three (3) exams, with the third exam given as the final. Each of the three (3) exams are weighted thirty percent (30%) of your final course grade. Exams will be a combination of essays and multiple-choice questions. Exams will cover the material from class lectures and assigned readings.
- Class participation and proper preparation is expected since it will greatly aid the learning process and enjoyment of the class. Class attendance will be measured regularly throughout the semester. Unscheduled quizzes and other assignments will be given as well. Students will not be penalized for the first three (3) unexcused absences on days when attendance is taken or a quiz is given. The total attendance and quiz points will count as 10% of your final course grade. Make-up quizzes will not be offered. If a student misses an attendance day or a quiz due to an excused absence, the weight of the missed attendance or quiz will be evenly distributed across the remaining days/quizzes. For an absence to be excused, twenty four (24) hours' notice must be given to the instructor (or as soon as possible in the case of an emergency). The instructor reserves the right to require appropriate documentation to substantiate any excused absence. If a student misses an attendance day or quiz (a) without a qualified excuse or (b) without giving timely notice to the instructor, they will receive a zero (0) for the missed attendance day or quiz.

• Final course grades and/or exams may be curved as necessary. The final grade cutoff points will not be known until the final exam is graded.

Exams: Exams will be taken in the Rawls College of Business Testing Center (the "Testing Center") during its normal hours of operation. The Testing Center's hours of operation may not coincide with the scheduled class times. <u>Any exam scheduling conflicts must be reported to the instructor no later than one (1) week prior to the first scheduled exam (see *Final Exam Date* for <u>details about the final exam schedule</u>). To ensure fairness to all students, aid pertaining to exam content will not be provided by instructors or teaching assistants during the testing period.</u>

¹ A Texas Instrument BA II Plus Calculator will be used for in-class examples and students are strongly advised to purchase a similar model (the Professional version is fine). An adequate financial calculator can be purchased for roughly \$30. At minimum, your calculator must be able to deal with uneven cash flows to calculate internal rates of return (IRR) and the net present value (NPV) of an investment. No programmable calculators, PDAs, computers, phones, or similar devices are allowed to be used on tests.

- Calculators are provided by the Testing Center. Students are not allowed to use their own calculator on exams.
- Make-up exams will only be allowed for excused absences that span the entire testing period for the applicable exam. For an absence to be excused, twenty four (24) hours' notice must be given to the instructor (or as soon as possible in the case of an emergency). The instructor reserves the right to require appropriate documentation to substantiate any excused absence. Make-up exams must be taken by the earlier of (a) one (1) week after the end of the applicable testing period or (b) the day before the date of the final exam. Scheduling a make-up exam is the student's responsibility. If a student misses an exam (a) without an excused absence, (b) without giving timely notice to the instructor or (c) without scheduling a timely make-up, the student will receive a zero (0) for the missed exam.

Final Exam Date: Students may elect one (1) of two (2) options for the Final Exam: 1) take the Final Exam at the Rawls Testing Center on Thursday, May 7th during the test availability window of 8am until noon (12pm), **OR** 2) take the Final Exam in the regular classroom (Rawls 287) on Friday, May 8th at 1:30pm. Students must email me their Final Exam option choice no later than 5pm on Friday, May 1st. The amount of time allowed for the Final Exam is the same for both options (2.5hrs or 150mins). Option 2 is the default election for students who fail to contact me before the election deadline (5pm on 5/1/2020) since the day and time are consistent with the Final Exam Schedule published by TTU.

Extra Credit: Extracurricular participation in the Texas Tech Real Estate Organization ("REO") will aid the learning process and enjoyment of the course. Extra credit (up to a maximum of 8 points) will be awarded in tiers as follows:

Tier 3 (maximum of 8 points)

- Complete 6 points of extra credit from Tier 1 and Tier 2 in order to be eligible for Tier 3

- Successfully complete Level Three of the REFM Certification Program in Excel for Real Estate (2 points)

V. <u>Other Details</u>

Texas Real Estate Licensing Exam: This course is <u>not</u> intended to prepare students for licensure pursuant the Texas Real Estate Licensing Act. For additional information on licensing, or non-credit correspondence courses, go to <u>www.educationstation.net</u>.

² To be clear, cheating on either attendance or a quiz will result in a zero for the entire 6% of the course grade related to attendance and quizzes because quizzes aid attendance tracking. In addition, attendance is a requisite for quiz eligibility so that these two grades are dependent upon one another and therefore inseparable.

³ One of the most common instances of cheating on attendance and quizzes is outlined in Part 1, Section B.1.a.7 of the <u>Texas Tech University Student Handbook</u>: "Substituting for another person, or permitting another person to substitute for oneself in order to take a course, take a test, quiz or other assignment or sign in/register attendance."
